At a scheduled meeting of bowlers held on OCT 13<sup>th</sup> 1947 and by a majority vote of those present, representing a majority of leagues (or teams) desiring to affiliate with the American Bowling Congress, a City Bowling Association was formed and officers and Executive Directors elected as set forth on the reverse side. It is understood that all future meetings will be held in accordance with the provisions outlined in the Constitution prescribed for City Associations.

A resolution was passed authorizing the officers to have our association become affiliated with the American Bowling Congress, and in accordance therewith we make formal application for membership and request a City Association Charter be granted.

This association has adopted the Constitution provided by the Congress and agrees that no amendments thereto shall be made which conflict with the A. B. C. Constitution, Rules and Regulations.

This association also agrees that it will abide by, and enforce the Constitution, Rules and Regulations of the American Bowling Congress. Its officers pledge to restrict competition in its sanctioned leagues and tournaments to bowlers who are not bowling in any unsanctioned league. It is further agreed that membership in the association shall be restricted in accordance with Section 4, Article 3, of the American Bowling Congress Constitution.

It is understood that the charter for our City Association will be automatically renewed each year as long as we live up to the requirements of the American Bowling Congress. However, should this association or its officers fail or refuse to comply with, or to enforce, the Constitution, Rules and Regulations of the American Bowling Congress, it is our understanding the charter is subject to revocation, in which event this City Association will surrender its charter and thereafter refrain from using the Association name and discontinue all representations that it is affiliated with the American Bowling Congress.

The Charter Membership of this Association is comprised of the following league or leagues and application for sanction for each league on a separate form is enclosed herewith, or forwarded under separate cover, together with annual A. B. C. dues of ONE DOLLAR AND FIFTY CENTS (\$1.50) for each team.

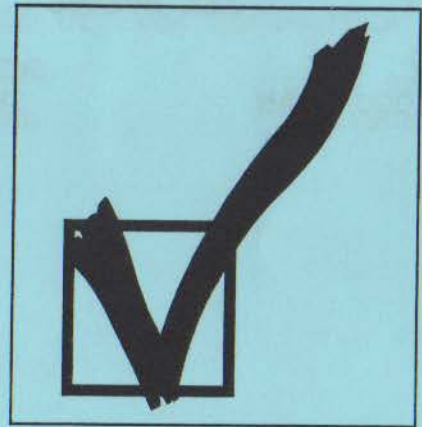
