OPEN DIVISION TOURNAMENT RULES

1. All persons sanctioned with the New Haven County USBC Bowling Association are eligible to bowl in this tournament. Any bowlers holding a PBA membership card are eligible to bowl in this tournament with the following provisions: Only one card holder will be allowed to bowl on a two person team and no more than two card holders would be allowed to bowl on a five person team.
2. The tournament shall be conducted on a handicap and non handicap basis with the handicap being determined as 100% of the difference of the bowlers average and 250. The average determination is as follows. 2021/2022 winter average minimum 21 games, if no winter average then 2022 summer average min 21 games. If bowler has neither then use average as of Oct. 31st 2022 min 21 games, if not bowler will bowl scratch.
League standing sheets will be required for all bowlers using their avg as of Oct. 31st 2022 in all their leagues.
Youth averages will be accepted. **ALL AVERAGES WILL BE VERIFIED. TOURNAMENT MANAGEMENT HAS THE RIGHT TO RE-RATE AVERAGES ACCORDING TO USBC RULE 319.**
3. **SPORT/CHALLENGE CONDITION BOWLERS:** If a bowler has both a sport/challenge condition average and a non sport condition average for the year, the non sport average will be used. If a bowler has only a sport/challenge condition average, the conversion chart in the USBC rule book will be used. If the bowler only has a sport/challenge condition average for 2022/23 season, the sport/challenge condition conversion will apply to the Oct. 31st 2022 average.
4. Ten Pin Rule - If a bowler's average is ten pins higher than the entering average, as of Oct. 31st 2022, that average must be used. This will include any games bowled on Oct. 31 2022 and prior.
Only Open division scores will be used for the Open division All Events total.
5. In the case of ties for any first place finish, co-champions will be declared. Awards will be awarded to all champions.
6. **Bowlers will be allowed multiple entries in all of the events; unlimited team, doubles, and singles with the exception of the optional "all Events" award, which may only be entered once. In case of doubles, a team can only cash once with the same partner. In the case of five person team, only three common bowlers (per team) will be allowed to cash. A bowler can only cash once in singles event.**
7. The prize fund will be returned 100% with 50% of prize money in each event (except all events) allocated to handicap and scratch prizes. All fees collected for All Events scratch and All events handicap will be returned to their respective divisions.
8. When a bowler competes in more than one singles, doubles, or team, their first scores count towards their A/E total
9. Team captains shall report to the tournament management 30 minutes prior to bowling to check in and verify line-ups. Lane assignments will be drawn by team captains.
10. These and other rules deemed necessary by the Tournament Management shall govern.
11. **WARNING TO ALL YOUTH BOWLERS:** you may jeopardize your amateur standing by bowling in this tournament or any other tournament where cash prizes are awarded.
12. Prize monies shall be distributed within 30 days of the completion of the tournament and the verification of averages.
13. **Dress code.** The team captain is responsible for his or her team members to follow the dress code as stated Participants (male and female) must wear a shirt with a butterfly collar or mock collar. U.B.A. shirts will be allowed providing they have sleeves, if the U.B.A. shirts have no sleeves, the bowler must wear a shirt with sleeves underneath Men may wear slacks, casual trousers or jeans. Women may wear skirts, slacks, casual trousers, skorts, culottes, or jeans. All clothing (mens or womens) must be neat, clean and have no holes or tears. Dress or casual shorts are allowed.
Clothing not allowed, cut off shorts, sweats, parachute pants and yoga pants. No hats are to be worn.
No profanity or vulgarity will be allowed on any clothing

WOMEN'S DIVISION RULES

14. All above rules apply unless specified in this section.
15. Only women bowlers are allowed in this division. No more than one woman bowler holding a PBA card may bowl on a four women team, and one woman card holder may bowl on a two woman team.
16. The team consists of four women bowlers.
17. Women's division All Events will consist of only women's division scores.
18. A woman may choose to use her women's singles and doubles scores for the OPEN tournament by paying an additional prize fee of \$32.00. Check the appropriate box on the entry form. (must be both sets of scores).
19. Only two common bowlers will be allowed to cash on multiple entries in team event.
